#### 5.1 EXTENSION OF DUE DATE FOR WATER RATES PAYMENTS

#### **EXECUTIVE SUMMARY**

Rates notices have been received late due to increased postage time from Melbourne to Mount Isa. The motion proposes an extension of time to Friday 24 September 2021 for due date or water rate notices.

#### RECOMMENDATION

**THAT** Mount Isa City Council extend the due date for water rate notices to Friday 24 September 2021.

#### **BACKGROUND**

Mount Isa City Council (MICC) set the date for rate notices and deliver the data to the printers in Melbourne. The notices are proofed by email, printed in Melbourne then mailed to the property owners. The current water rates were dated 4 August but were received by residents on 25 August. The legislative requirement under the Local Government Regulations 2012 section 118 (2) (a) is that ratepayers must be given 30 days to pay and that it must be the same date for all ratepayers. Only Council by way of a resolution can set this date.

This is likely to be an ongoing issue, namely with the delay in processing postage from Melbourne to Mount Isa, albeit that this instance has been further influenced due to COVID restrictions. In the future Mount Isa City Council will adjust the reading and issue dates accordingly.

The alternative is not to extend the date and charge interest on unpaid accounts. In law the notice period is usually deemed to be from the date the notices were posted, not received. This approach would not foster good relations between Mount Isa City Council and the community it serves.

#### **BUDGET AND RESOURCE IMPLICATIONS**

The change of dates will affect cash flow but not the financial results of Mount Isa City Council. The delay to receipt of revenue is not considered significant
