



## Payment Commitment Application – Rates & Water Consumption Notices

This form is used to apply for a payment commitment for outstanding rates and charges / water consumption charges and/or, if you are unable to make full payment of your Rates and/or Water Consumption Notices by the due date.

As per the Local Government Regulation, Chapter 4, Section 133 (1) interest is payable on overdue rates and charges. All approved payment commitments for outstanding rates and charges / water consumption charges will continue to accrue interest at a rate of 8% per annum compounding daily until the outstanding amount is paid in full.

Completion and submission of this payment commitment application form is not enough to stop your account from being referred to Council's external debt recovery agency or taking further legal action.

Council will provide written confirmation of an approved payment commitment once your application has been processed. Council encourages you to commence payments immediately whilst your application is being reviewed. <u>Please Note:</u> this application is **not** an approval of your request.

As per Council's current Financial Year – Rates & Charges Debt Recovery Policy, your payment commitment should result in all outstanding rates & charges / water consumption charges being paid in full within six (6) months. If you are unable to keep to your agreed payment commitment, you are required to contact Council **prior** to it being due.

If your payment commitment is not maintained within the agreed terms the following actions will occur:

- Your payment commitment will be cancelled; and
- All outstanding rates and charges / water consumption charges will be forwarded to Council's external debt recovery agent without further notice to you.
