Deputy Mayor, Cr Barwick informed Council that the Mayor Cr McCulloch, Cr MacRae and the Chief Executive Officer have been delayed and will be attending the meeting late.

Member of the Public – Ms Danielle Slade

Ms Slade requested that Council grant amnesty to all home owners who have a 25mm water meter or larger water meter and an amnesty to all business owners that their water charges should only be increased no more than 3 percent for the 2018/19 financial year.

Ms Slade commented that since Council introduced the water charges without community engagement, Council had an obligation that no home, family or business be placed in financial hardship as this did not allow enough time for residents to budget or work out the terms of arrangement on the changes. Ms Slade requested that Council consider this request in their next Council Workshop.

Deputy Mayor, Cr Barwick responded saying there are no usage charges being applied until next year, allowing 6 months for people to assess their position and that Council is looking at all applications of request dealing with them in a timely manner. Requests that haven't been answered will be answered and Council will be addressing those that need addressing.

Member of the Public – Mr Glen Ashmore

Mr Ashmore stated he represented the businesses in the community and enquired why the delay to his request in September had not been dealt with regarding his water charges to one of his properties. Mr Ashmore also expressed his concerns on issues with water meter charges to his other properties.

Deputy Mayor, Cr Barwick responded that Mr Ashmore contact the CEO if he doesn't receive a response in the next 7 days and that Council is considering all situations.

Member of the Public – Mr Guido Pittis

Mr Pittis commented on his situation with the access amount he was charged and had met with Council staff but is still waiting to hear an answer. Mr Pittis expressed his concern with not being able to meet payment due to the charges.

Deputy Mayor, Cr Barwick said he couldn't comment on individual cases and reiterated to contact the CEO if no response is received in the next 7 days.

Member of the Public – Ms Danielle Slade

Ms Slade requested permission to ask another question.

Deputy Mayor, Cr Barwick informed Ms Slade that she had already been permitted to ask her question and requested that she bring her question to the next Council meeting.
