If your meter is found to be reading **outside** of the Australian Water Meter Standards, the following will occur:

- Your application fee will be refunded
- The water meter will be replaced at no cost to the owner
- Council will review your Water Consumption Notice

How Council will test your meter:

The certified plumber will attach a test meter in series to the property meter which is to be tested. An opening read will be recorded, 100 litres of water will pass through the test meter and then onto the property meter or in the opposite configuration. Once the test is complete, a closing read will be recorded. The final reading must not be greater or lower than 5% of the amount tested (e.g. for every 100 litres tested the meter read cannot be below 95L or above 105L) in accordance with the prescribed standard.
